Privacy Policy

1) Introduction

This Privacy Policy governs the manner in which the European College of Polytechnics (referred to as 'we', 'us', or 'our') collects, uses, maintains, and discloses information collected from users (each, a 'User') of our website. This privacy policy applies to the website and all products and services offered by the European College of Polytechnics.

2) Definitions and Interpretation

Data: Refers to any information submitted by Users through our website, including personal data as defined under the General Data Protection Regulation (GDPR).

4) Data Collection

Users may be asked for, as appropriate, name, email address, mailing address, phone number, and credit card information.

5) How We Use Collected Data

The European College of Polytechnics may use Users' personal data for the following purposes: (a) To improve ECP's service (b) To personalise user experience (c) To process payments (d) To comply with the law.

We will retain and use your information to the extent necessary to comply with our legal obligations, resolve disputes, and enforce our agreements.

6) Data Protection

We adopt appropriate data collection, storage, and processing practices and security measures to protect against unauthorised access, alteration, disclosure, or destruction of your personal data stored on our site.

7) User Rights

Under GDPR, Users have the right to access, rectify, erase, restrict processing, object to processing, and data portability concerning their data. Users can exercise these rights by contacting us.

We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic, and managerial procedures to safeguard and secure the information we collect online. If accessing certain sections of our website necessitates a password, the responsibility for maintaining the confidentiality of this password rests solely with you. The European College of Polytechnics urges you not to share your password with anyone, to prevent unauthorised access to your personal

account and data. The European College of Polytechnics is dedicated to safeguarding your personal information with the utmost care and security measures. However, it is important to acknowledge that the transmission of data over the internet carries inherent risks and may not be completely secure. As such, any information you transmit to or from our website is at your own risk. We strive to use appropriate security measures to protect your data, but we cannot guarantee the absolute security of information sent to our website.
