

General terms and condition

These are the conditions (the "agreement") that govern your participation in the conference (hereinafter referred to as the "Event"), which is being organized by European Cultural Point (hereinafter referred to as "ECP"). By registering or paying the participation fee for the Event, you agree to these conditions, which constitute a legally enforceable contract between ECP and the registered participant (hereafter referred to as "you").

1. TERMS OF PAYMENT

ECP requires full payment of the conference participation fee in advance. After ECP receives payment, an invoice will be emailed to the participant's email address specified on the registration form. The participation fee covers access to the conference sessions as well as entry to the event's networking social breaks. Lunch, travel, accommodations, transportation, insurance and any other cost are not included in the participation fee.

2. ACCOMMODATION

The participation cost does not include overnight accommodations. Participants may be eligible for a discounted rate at the partner hotel (s).

3. PARTICIPANT CANCELLATION.

The participant has the ability to withdraw from the event. ECP must receive cancellations notice in written. Participation fees are non-refundable in the event of cancellation. No changes or replacements to any registration are permitted under any circumstances.

4. TERMINATION BY THE ECP.

While every reasonable effort is made to adhere to the stated program, situations beyond ECP's control may result in program modifications, including but not limited to changes to the event's name, substance, date(s), location or venue, or special features. These circumstances may include, but are not limited to, acts of terrorism, war, extreme weather conditions, compliance with government requests, orders, and legal requirements, the inability of third-party suppliers to deliver on time, and the inability to register the minimum targeted number of attendees for a given event. You acknowledge that ECP is not responsible for any fees, losses, or expenditures incurred by you as a result of the event being modified, combined with another event, postponed, or cancelled.

5. EVENT CANCELLATION.

If ECP cancels the event, ECP may give you a credit for the amount you paid to ECP. This credit is valid for up to one year from the invoice date for participation at any future ECP events.

6. IDENTIFICATION DATA.

By registering for the Event and agreeing to these terms and conditions, you grant ECP full permission to share your identifying information, including but not limited to your name, address, affiliation, email address, phone number, and the names of representatives, with third parties who attended the same event as you.

7. EXCLUSION.

ECP has the right to deny registration to any participant who does not conform to the conference structure and idea, in ECP's view.

8. REIMBURSEMENT OF THE PARTICIPATION FEE.

The conference organizers will make every effort to accomplish the conference's aim, which will need the cooperation of all academics who share the same ambition, as well as the necessary funds to pay the conference's operating expenses. Thus, under no circumstances is the participation fee refunded.

9. CONCLUSIVE DISPOSITIONS.

ECP retains the right, in its sole and absolute discretion, to use the conference's videos, audio recordings, and/or photos in any medium for publicity, advertising, trade, or promotion reasons without obtaining permission from participants and without payment of any kind. Any participant in the conference agrees to renounce their intellectual property rights in connection with event and/or published in the way specified here.

ECP retains the right, at any time and without notice, to amend any of its General Terms and Conditions. This contract is enforceable under Estonian law.
